The Clerk of the Board of Supervisors issues business licenses **only** for the unincorporated areas of the County. Businesses operating within an incorporated city must contact that city and be licensed in accordance with individual city requirements. There is no business license available that covers the entire County. The following types of businesses are required to have a **COUNTY BUSINESS LICENSE** in order to operate in an unincorporated area:

 Bingo (Regular & Remote Caller) Massage Clinic
 Peddler Private Patrol
 Solicitor Taxicab Service
