

# NEED DIRT???



Effective July 19, 2012, the San Bernardino County Flood Control District will be selling material through the open proposal process for requested quantities which exceed 10,000 cubic yards.

Proposers will be required to submit a proposal typically within one week after solicitation. Proposals will include but not be limited to, the quantity of material to be removed, the unit price, past performance with the District, and the anticipated duration of removal. The District will use these factors to evaluate and select the proposer who can provide the best service to the District. The District will continue to charge the applicable filing and inspection fees.

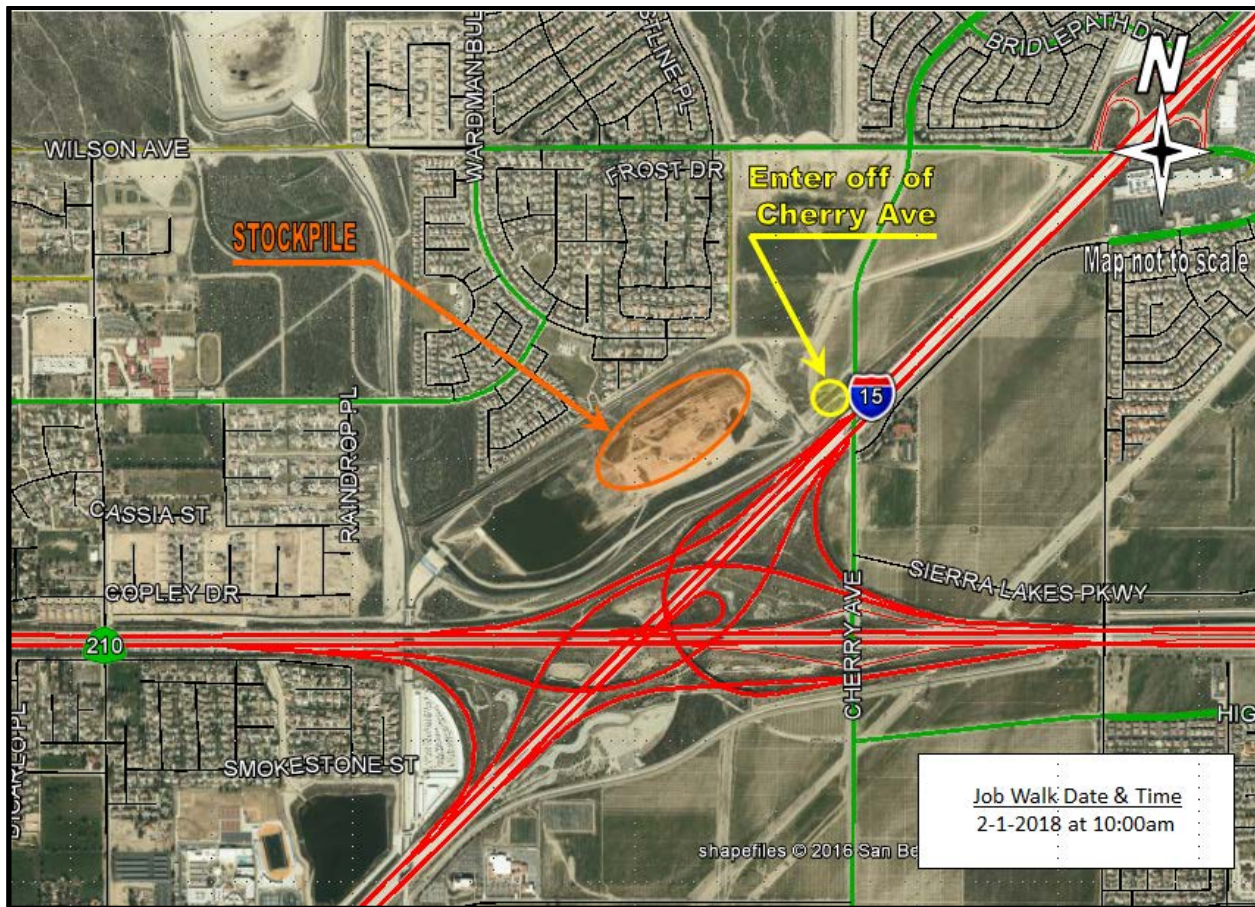
