The District Attorney of the County of San Bernardino, by this Information alleges that:

COUNT 1

On or about October 17, 2007, in the above named judicial district, the crime of BRIBING A MINISTERIAL OFFICER, in violation of PENAL CODE SECTION 67.5(b), a felony, was committed by Arshak Aroush Kouladjian and Vartan Aroush Kouladjian, who did, with a corrupt intent to unlawfully influence a ministerial officer, employee, or appointee of the State of California, county or city therein, or political subdivision thereof, to wit: Robert Kevin Page, in respect to an act, decision, vote, opinion and proceeding of said Robert Kevin Page in his public or official capacity, give and offer to give a bribe of \$15,000.

COUNT 2

On or about January 3, 2008, in the above named judicial district, the crime of BRIBING A MINISTERIAL OFFICER, in violation of PENAL CODE SECTION 67.5(b), a felony, was committed by Arshak Aroush Kouladjian and Vartan Aroush Kouladjian, who did, with a corrupt intent to unlawfully influence a ministerial officer, employee, or appointee of the State of California, county or city therein, or political subdivision thereof, to wit: Robert Kevin Page, in respect to an act, decision, vote, opinion and proceeding of said Robert Kevin Page in his public or official capacity, give and offer to give a bribe of \$15,000.

COUNT 3

On or about February 13, 2008, in the above named judicial district, the crime of ATTEMPTED BRIBING A MINISTERIAL OFFICER, in violation of PENAL CODE SECTION 664/67.5(b), a felony, was committed by Arshak Aroush Kouladjian and Vartan Aroush Kouladjian, who did, with a corrupt intent to unlawfully influence a ministerial officer, employee, or appointee of the State of California, county or city therein, or political subdivision thereof, to wit: Robert Kevin Page, in respect to an act, decision, vote, opinion and proceeding of said Robert Kevin Page in his public or official capacity, attempt to give and offer to give a bribe of \$15,000.
