The District Attorney of the County of San Bernardino, by this Information alleges that:

COUNT 1

On or about December 7, 1995, in the above named judicial district, the crime of WILLFUL, DELIBERATE, AND PREMEDITATED MURDER, in violation of PENAL CODE SECTION 187(a), a felony, was committed by Duree Graves Pettress, who did unlawfully and with malice aforethought attempt to murder Tycoon Vennie Graves , a human being.

It is further alleged that the aforesaid attempted murder was committed willfully, deliberately and with premeditation within the meaning of Penal Code section 664(a) and is a serious felony pursuant to Penal Code section 1192.7(c).

COUNT 2

On or about December 7, 1995, in the above named judicial district, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a felony, was committed by Lafayette Pettress, who did unlawfully, and with malice aforethought murder Tycoon Vennie Graves , a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c) and a violent felony within the meaning of Penal Code section 667.5(c)."

"NOTICE: Conviction of this offense will require you to provide specimens and samples pursuant to Penal Code section 296. Willful refusal to provide the specimens and samples is a crime."
