The undersigned is informed and believes that:

COUNT 1

On or about January 1, 2007 through February 13, 2009, in the above named judicial district, the crime of GRAND THEFT, in violation of PENAL CODE SECTION 487(a), a felony, was committed by William John Postmus, who on and between January 1, 2007 and February 13, 2009, and while said defendant was an agent, servant, and employee of San Bernardino County, did unlawfully take from said San Bernardino County money and personal property of a value exceeding Four Hundred Dollars (\$400).

COUNT 2

On or about January 1, 2007 through February 13, 2009, in the above named judicial district, the crime of PUBLIC OFFICER CRIME, in violation of PENAL CODE SECTION 424, a felony, was committed by William John Postmus, who being a person described in Penal Code section 424 charged with the receipt, safekeeping, transfer, and distribution of public moneys, did in a manner not incidental and minimal without authority of law, appropriate the same, and a portion thereof, to personal use and the use of another.

COUNT 3

On or about January 8, 2007 through January 16, 2009, in the above named judicial district, the crime of GRAND THEFT, in violation of PENAL CODE SECTION 487(a), a felony, was

committed by Gregory Scott Eyler, who on and between January 8, 2007 and January 16, 2009, and while said defendant was an agent, servant, and employee of San Bernardino County, did unlawfully take from said San Bernardino County money and personal property of a value exceeding Four Hundred Dollars (\$400).

COUNT 4

On or about January 8, 2007 through January 16, 2009, in the above named judicial district, the crime of PUBLIC OFFICER CRIME, in violation of PENAL CODE SECTION 424, a felony, was committed by Gregory Scott Eyler, who being a person described in Penal Code section 424 charged with the receipt, safekeeping, transfer, and distribution of public moneys, did in a manner not incidental and minimal without authority of law, appropriate the same, and a portion thereof, to personal use and the use of another.

COUNT 5

On or about January 1, 2007 through February 13, 2009, in the above named judicial district, the crime of GRAND THEFT, in violation of PENAL CODE SECTION 487(a), a felony, was committed by William John Postmus, who on and between January 1, 2007 and February 13, 2009, and while said defendant was an agent, servant, and employee of San Bernardino County, did unlawfully take money and personal property of a value exceeding Four Hundred Dollars (\$400),

COUNT 6

On or about September 12, 2008 and January 15, 2009, in the above named judicial district, the crime of PUBLIC OFFICER CRIME, in violation of PENAL CODE SECTION 424, a felony, was committed by William John Postmus, who being a person described in Penal Code section 424 charged with the receipt, safekeeping, transfer, and distribution of public moneys, did in a manner not incidental and minimal without authority of law, appropriate the same, and a portion thereof, to wit, an AT&T Wireless "Air Card", to personal use and the use of another.

COUNT 7

On or about February 26, 2007 and March 22, 2007, in the above named judicial district, the crime of GRAND THEFT, in violation of PENAL CODE SECTION 487(a), a felony, was

committed by William John Postmus, who on and between February 26, 2007 and March 22, 2007, and while said defendant was an agent, servant, and employee of San Bernardino County, did unlawfully take money and personal property of a value exceeding Four Hundred Dollars (\$400).

COUNT 8

On or about February 26, 2007 and March 22, 2007, in the above named judicial district, the crime of PUBLIC OFFICER CRIME, in violation of PENAL CODE SECTION 424, a felony, was committed by William John Postmus, who being a person described in Penal Code section 424 charged with the receipt, safekeeping, transfer, and distribution of public moneys, did in a manner not incidental and minimal without authority of law, appropriate the same, and a portion thereof, to wit, Southwest Airline Airfare, to personal use and the use of another.

COUNT 9

On or about June 20, 2006 through July 5, 2006, in the above named judicial district, the crime of PUBLIC OFFICER CRIME, in violation of PENAL CODE SECTION 424, a felony, was committed by William John Postmus, who being a person described in Penal Code section 424 charged with the receipt, safekeeping, transfer, and distribution of public moneys, did in a manner not incidental and minimal without authority of law, appropriate the same, and a portion thereof, to wit, the purchase of gasoline, to personal use and the use of another.

COUNT 10

On or about March 28, 2009, in the above named judicial district, the crime of PERJURY BY DECLARATION, in violation of PENAL CODE SECTION 118, a felony, was committed by Willilam John Postmus, being a person who testified, declared, deposed and certified under penalty of perjury in a case in which such testimony, declaration, deposition and certification is permitted by law under penalty of perjury, did state as true a material matter which he knew to be false and delivered such testimony, declaration, deposition and certification with the intent it be published as true to wit: failed to claim or disclose receipt of a \$12,000 cashiers check as an asset, income, gift, or any other source, on Fair Political Practice Commission Statement of Exonomic Interest form 700.

COUNT 11

On or about January 15, 2008, in the above named judicial district, the crime of POSSESSION OF A CONTROLLED SUBSTANCE, in violation of HEALTH AND SAFETY CODE SECTION 11377(a), a felony, was committed by William John Postmus, who did unlawfully possess a controlled substance, to wit, Methamphetamine.

"NOTICE: Conviction of this offense will require you to register pursuant to Health and Safety Code section 11590. Failure to do so is a crime pursuant to Health and Safety Code section 11594."

COUNT 12

On or about January 15, 2008, in the above named judicial district, the crime of POSSESSION OF A CONTROLLED SUBSTANCE, in violation of HEALTH AND SAFETY CODE SECTION 11377(a), a felony, was committed by William John Postmus, who did unlawfully possess a controlled substance, to wit, Methylenedioxymethamphetamine (Ecstasy).

"NOTICE: Conviction of this offense will require you to register pursuant to Health and Safety Code section 11590. Failure to do so is a crime pursuant to Health and Safety Code section 11594."

COUNT 13

On or about January 15, 2008, in the above named judicial district, the crime of POSSESSION OF PARAPHERNALIA FOR UNLAWFUL USE, in violation of HEALTH AND SAFETY CODE SECTION 11364(a), a misdemeanor, was committed by William John Postmus, who did unlawfully possess a device, contrivance, instrument, and paraphernalia used for smoking and unlawfully injecting and ingesting a controlled substance.
