## **PARK OVERVIEWS**

### *Prado*

Master Plan – The TAC and CAC meetings will be held on May 16<sup>th</sup>. The Master Plan presentation to the Commission will be at the July meeting. The presentation will be extensive and lengthy.

### *Calico*

The contract for Lanes General Store was not renewed. The concessionaire has until May 15<sup>th</sup> to remove their property. Historical artifacts belonging to the County have been removed, packed and stored with assistance from San Bernardino County Museum staff. Historical items will be returned when the new concessionaire takes over. Proposals have been submitted by prospective concessionaires. Interviews have been scheduled.

### *Cucamonga Guasti*

The pool will not open this summer. The pool replacement was presented at the Budget workshop along with the waterslide at Glen Helen, the rehabilitation of group tent sites at Yucaipa, and removal of the buildings at Camp Switzerland. Blane McNally is the new Assistant Park Superintendent at Cucamonga Guasti.

### *Lake Gregory*

Mrs. Davis distributed the RFP brochure to commission members. The department is looking for a partner. Discussion was held regarding Camp Switzerland, preserving the beauty of the park, and increasing visitor usage in the area. The RFP Proposal Conference is scheduled for May 20<sup>th</sup>. Commissioner Mitchell asked if the wedding cabin would go to the new concessionaire. Mrs. Davis responded yes.

### *Mojave Narrows*

The final walk through was held for the playground resurfacing project. The fencing will be removed today or tomorrow. The sand has been replaced with a pour and play surface. The playground looks great. A tire swing will be added in June. A meeting with Real Estate Services is scheduled at Mojave Narrows tomorrow regarding Prop 68 funding. Steve Lampignano is the new Park Ranger II. He came from Agriculture Weights and Measures.

### *Mojave River Forks*

A copy of the lease was sent back to the Army Corps of Engineers with comments.

### *Glen Helen*

The park has hired enough lifeguards to open. A new pool manager has been hired from Yucaipa. A proposal for the snack bar has been received. An interview has been scheduled. One water slide will be open this summer. Pool preparation is in process.

### *Big Morongo Preserve*

No report.

*Moabi*

Contract negotiations are in process with the concessionaire.

*Yucaipa*

Pool prep is almost complete. The electrical project is complete. There is an upcoming CDBG project that will upgrade the restrooms/showers in the RV area.

Mrs. Davis stated she met with the State regarding grant opportunities for Regional Parks. Some of the applications are due in January. The grant Mojave Narrows qualifies for is due in August. There will be a third grant program only for Regional Parks.

Commissioner Mitchell requested dates be provided to visit Moabi. Mrs. Davis commented we will try to schedule this visit during the fall.

*Santa Ana River Trail*

The trail will be swept on May 22<sup>nd</sup> in the morning.
