STRUCTURAL PEST CONTROL BUSINESS REGISTRATION

**Registration must be submitted prior to performing any pest control work
in San Bernardino County in 2021.**

Chapter 14, California Business & Professions Code § 8505 defines pest control as:

(a) "Structural pest control" and "pest control" as used in this chapter [Chapter 14] are synonymous. Except as provided in § 8555 and elsewhere in this chapter, it is, with respect to household pests and wood destroying pests or organisms, or other pests that may invade households or other structures, including railroad cars, ships, docks, trucks, airplanes, or the contents thereof, the engaging in, offering to engage in, advertising for, soliciting, or the performance of, any of the following: (1) Identification of infestations or infections. (2) The making of an inspection or inspections for the purpose of identifying or attempting to identify infestations or infections of household or other structures by those pests or organisms.

(3) The making of inspection reports, recommendations, estimates, and bids, whether oral or written, with respect to those infestations or infections. (4) The making of contracts, or the submitting of bids for, or the performance of any work including the making of structural repairs or replacements, or the use of pesticides, or mechanical devices for the purpose of eliminating, exterminating, controlling or preventing infestations or infections of those pests, or organisms.

Separate registration forms and fees are required for BRANCH 1 and BRANCH 2/3

BRANCH 1 (Fumigation)

Submit a Branch 1 Registration form and payment of **\$25.00**.

BRANCH 2 (General Pest)

BRANCH 3 (Wood Destroying Organisms)

Submit a Branch 2/3 Registration form and payment of **\$10.00**.

(Companies licensed in both Branch 2 & 3: submit only one registration form and \$10.00 fee.)

Pesticide Use Reports (including "Negative Use" reports) are to be submitted online using the CalAgPermits website (www.calagpermits.org). If you cannot access the CalAgPermits, please contact our office.
